236016 C.J. COMPARED ORDINANCE NO. 55

AN ORDINANCE adding to the City of Sand Springs the real estate and premises known
as Hillcrest Addition to the City of Sand Springs, according to the recorded plat thereof,
extending the City limits so as to include said Addition, adding said Addition to Ward No.
One of the City of Sand Springs, and declaring an emergency;

WHEREAS, the owner of the real estate and premises known as Hill Crest Addition
has caused said lands to be platted, and has filed a plat of the same in the office of the
County Clerk of Tulsa County, State of Oklahoma, and said real estate, as shown by said
plat, having been divided into tracts, lots or parcels of land of less than five (5) acres,
and the streets and alleys have been dedicated to the Public use forever, and whereas said pre
mises lies adjacent to the City of Sand Springs, and

WHEREAS, the owners of said real estate and premises have filed a petition asking
that said real estate and premises known as Hillcrest Addition to the City of Sand Springs,
according to the recorded plat thereof, be added to the City of Sand Springs, and that the
City limits of Sand Springs be extended to include said addition;

NOW THEREFORE, Be it ordained by the Mayor and City Commissioners of the City of
Sand Springs as follows:

Section 1. Hillcrest Addition to the City of Sand Springs, according to the recorded
plat thereof, the same comprising the following described real estate and premises, situated
in Tulsa County, State of Oklahoma, to-wit:

Beginning at the 1/4 corner on the North line of Section 11, T.19 N. R. 11 E.,
thence East along the Section line a distance of 960 feet; thence North a
distance of 1893.3 feet; thence West a distance of 960 feet; thence South a
distance of 1890.6 feet to the point of beginning, all in the S.E. 1/4 of

Section 2, T. 19 N., R. 11, E.;

is hereby added to the City of Sand Springs, Oklahoma, and the City limits of the City
of Sand Springs, Oklahoma, are hereby extended so as to include said Addition, and the
real estate and premises comprising same, as hereinabove described.

Section 2. Said real estate and premises, known as Hillcrest Addition to the City
of Sand Springs, according to the recorded plat thereof, is hereby added to Ward One
of the City of Sand Springs, Oklahoma.

Section 3. From and after the taking effect of this Ordinance said Hillcrest Addi-
tion to the City of Sand Springs and the streets and alleys therein shall be subject to
all the ordinances, easements, franchises, grants and contracts which are now or which may
