QUIT CLAIM DEED

THIS INDENTURE, made this 21st day of May, A. D., 1923, between The National Supply Company, a corporation organized under the laws of the State of Ohio, with its principal office in the City of Toledo, Lucas County, Ohio, of the first part, and The National Supply Company-Midwest, a corporation organized under the laws of the State of Delaware, of the second part; WITNESSETH:

That the said party of the first part, in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, quit-claim and convey unto the said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Tulsa, and State of Oklahoma, to-wit:

Beginning at the northeast corner of the northeast quarter of the Southeast quarter of Section Thirty-one (31), Township Twenty (20) North, Range Thirteen (13), East, Tulsa County, Oklahoma; thence South 286 feet to a point; thence South 67 degrees West 1141.34 feet to a point; thence South 23 degrees East 200 feet to a point; thence south 67 degrees West 377.55 feet to a point; thence North 1063.6 feet to a point; thence east 1320 feet to the place of beginning, and containing 18.69 acres more or less, and excepting right - of - way used by Frisco R.R. for a spur track, being the property deeded to the first party herein by the Atlantic Petroleum Co., on the 17th day of July, A. D., 1919, and recorded on the 6th day of August, 1919, in Book 292, page 183.
