QUIT CLAIM DEED

THIS INDENTURE made this 21st day of May, A. D., 1923, between The National Supply Company, a corporation organized under the laws of the State of Ohio, with its principal office in the City of Toledo, Lucas County, Ohio, of the first part, and The National Supply Company- Midwest, a corporation organized under the laws of the State of Delaware, of the second part; WITNESSETH:

That the said party of the first part, in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, quit-claim and convey unto the said party of the second part, its successors and assigns, all of the following described real estate situate in the County of Tulsa, and State of Oklahoma, to-wit:

All of Lot Four (4), Block 53, City of Tulsa, excepting the Missouri, Kansas & Texas right-of-way, according to the recorded plat thereof;

Also the easterly one hundred (100) feet of Lot Three (3), and the Easterly one hundred (100) feet of the Southerly one-half of Lot Two (2), all in Block Fifty-four (54) in the City of Tulsa, Oklahoma, and according to the official plat and survey thereof;

Also the westerly forty (40) feet of Lot Three (3) and the Westerly forty (40) feet of the Southerly one-half (1/2) of Lot Two (2) in Block Fifty-four (54) in the City of Tulsa, County of Tulsa, and State of Oklahoma, according to the Official Plat and survey thereof;

And the North fifty (50) feet, being the North one-half (1/2) of Lot Two (2) in Block Fifty-four (54), Tulsa, Oklahoma, as shown by the recorded plat thereof.

Being the property deeded to the first party herein by The National Supply Co. of Kansas on the 25th day of June, 1917, as recorded on the 18th day of April, 1919, in Book 268, Page 334.

Also, Lot Five (5), Block Fifty-four (54), City of Tulsa, County of Tulsa, State of Oklahoma.

Being the property deeded to the first party herein by R. B. Wasson and Irmel C. Wasson on the 7th day of January, 1918, as recorded on the 5th day of February, 1918, in Book 223, page 190.

Also, Lots six, (6), and Seven, (7) in Block Fifty-four (54) in the City of Tulsa, County of Tulsa, State of Oklahoma, according to the official plat thereof.

Being the property deeded to the first party herein by William F. Brown and Martha L. Brown on the 27th day of March, 1917, as recorded on the 2nd day of April, 1917, in Book 211, page 24.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in any wise appertaining forever.
