NOW THEREFORE, for and in consideration of One Dollar (and other good and valuable considerations) the receipt of which is hereby acknowledged, the undersigned, the present owner of said lease and all rights thereunder or incident thereto does hereby bargain, sell, transfer, assign and convey all right, title and interest of the original lessee and present owner, in and to the said lease and rights thereunder, together with all personal property used or obtained in connection therewith to The Independent Oil and Gas Company and its successors and assigns, insofar as it covers the East Half of the North East Quarter of Section Thirty Six (36) and an undivided One Half Interest in and to the East Half of the North West Quarter of Section Thirty Six (36) all in Township Seventeen (17) North, Range Thirteen (13) East.

And for the same consideration, the undersigned for himself and his heirs, successors and representatives does covenant with the said assignee, its successors or assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith;

That the undersigned has good right and authority to sell and convey the same and that said rights, interests and property are clear from all liens and incumbrances and that all rentals and royalties due and payable thereunder have been duly paid; and that the undersigned will warrant and defend the same against the lawful claims and demands of all persons whomsoever.
