It being, however, agreed and understood that after the completion of first well that the said second party hereto is to bear his proportionate part of his expenses in the further drilling of wells on said lease.

Party of the first part covenants that he is the lawful owner of said lease and rights and interests thereunder, and that he has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear of all liens and incumbrances.
