RELEASE AND SATISFACTION

KNOW ALL MEN BY THESE PRESENTS:

That Whereas, a certain action for divorce and alimony is now pending in the District Court of Tulsa County, Oklahoma, wherein Cordelia Chisholm is plaintiff and John Chisholm is defendant, said action being numbered No. 21565 on the records and docket of said court and having been filed in said Court on the 15th day of December, 1922, and

WHEREAS, said plaintiff and defendant did on or about the 26th day of December, 1922, enter into certain stipulations providing for the payment to said plaintiff by said defendant of the sum of \$500.00 for herself and \$200.00 for the use and benefit of her children by said defendant, making a total amount of Seven Hundred (\$700.00) Dollars to be paid said plaintiff by said defendant in full settlement of all her claims for alimony for herself and children, said stipulations being made to settle the property rights of said parties and to be filed in said action for divorce and alimony.

NOW THEREFORE, I, the said Cordelia Chisholm, for and in consideration of the sum of SEVEN HUNDRED & NO/100 (\$700.00) DOLLARS, to me in hand paid by said John Chisholm, receipt of which is hereby acknowledged, have remitted, released and forever discharged, and by these presents do for myself and for my heirs, executors and administrators, remise, release and forever discharge the said John Chisholm, his heirs, executors, administrators and assigns of and from all, and all manner of action and actions, cause and causes of actions, suits, debts, dues, sums of money, accounts, reckonings, contracts, controversies, executions, claims and demands whatsoever in law or in equity which I ever had, now have or may have against said John Chisholm by reason of the above mentioned stipulations or by reason of any claims for alimony or attorney fees claimed in my petition filed in the above mentioned action for divorce and alimony. I acknowledge full satisfaction of said stipulations.

I further acknowledged the payment of \$100.00 Attorney's fee to L. H. Taylor, my attorney in said action, by said John Chisholm.
