THIS INDENTURE OF LEASE, made in duplicate, this 28th day of July, 1923 by and between Lena E. McAnally & Lorena Kubatzky of the first part thereinafter called party of the first part whether one or more) and Alhambra Theatres Co. a Corporation of second part, (hereinafter called party of the second part, whether one or more.)

WITNESSETH: That the party of the first part, for and in consideration of the rents, covenants and agreements hereinafter contained, does, and by these presents, demise lease and rent for a period of 5 years from the First day of September, 1923, to the party of the second part, the following described property, to-wit:

The building and ground located on part of lots one two and three Broadmoor Heights Addition to the City of Tulsa, being the said building fronting West on Peoria Avenue, near the Corner of Fifteenth Street, in the said City of Tulsa, except two store rooms, but including outside walls.

The party of the second part, for and in consideration of the use and possession of said premises for said period, does hereby agree to pay unto the party of the first part the sum of (\$28,800.00) Twanty Eight Thousand Eight Hundred Dollars, said sum to be paid in the following amounts and at the times therein designated, to-wit:
