Lot two (2) in Block Eleven (11) Subdivision of block six (6) and Lots one (1), two(2) and Three (3) in Block Four (4) Terrace Drive Addition to the City of Tulsa, County of Tulsa, State of Oklahoma, according to the recorded plat thereof,

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining forever.
