237520 C.J. COMPARED RESOLUTION

WHEREAS, W. A. VANDEVER, the holder of the legal title, and THE TULSA LIVE STOCK & INDUSTRIAL EXPOSITION, a Corporation, holder of the equitable title of the

Southeast quarter of Southwest quarter (SE/4. SW/4) of Section Nine (9),

Township Nineteen (19) North, Range Thirteen (13) East, in Tulsa County,

Oklahoma,

have made a proposition to the Directors of the TULSA COUNTY FREE FAIR ASSOCIATION, to convey said property for fair purposes to DAVID A. WILSON and EXCHANGE TRUST COMPANY, a Corporation, Trustees for said Tulsa County Free Fair Association,

NOW, THEREFORE, BE IT RESOLVED by the Directors of the Tulsa County Free Fair Association that said conveyance to said David A. Wilson and Exchange Trust Company, as Trustees, be and the same is hereby accepted.

BE IT FURTHER RESOLVED that at any time the said Directors of the Tulsa County Free Fair Association deem it expedient to sell and dispose of said property by a majority vote of said Board, at a meeting called for that purpose, the said Trustees so named in said deed of conveyance, shall execute proper deeds of conveyance to the purchasers as directed by the Directors of said Tulsa County Free Fair Association.

BE IT FURTHER RESOLVED that in case said Board of Directors of said Tulsa County Free Fair Association, shall, by a majority vote at a meeting called for that purpose, authorize the sale of said property, the selling price thereof, or the consideration received from the sale of said property shall be used by the Board of Directors of the Tulsa County Free Fair Association in acquiring other property and buildings for fair purposes.

BE IT FURTHER RESOLVED That in case the Tulsa County Free Fair Association shall not authorize and direct the Trustees to make conveyance of said property, and shall abandon said property so received from the said W. A. Vandever and the Tulsa Live Stock & Industrial Exposition for fair purposes, for a period of three (3) years, then said property shall become the property of Tulsa County, and the Trustees are hereby directed in case of such abandonment for three years, to execute a conveyance to Tulsa County for said premises, together with all appurtenances and buildings located thereon.

BE IT FURTHER RESOLVED by said Board of Directors of said Tulsa County Free Fair Association that in case it becomes necessary to borrow money or funds for the improvement of said property or the erection of buildings thereon to be used for fair purposes, that the Board of Directors of said Tulsa County Free Fair Association shall, by a ma-
