Wilson and Exchange Trust Company to pledge said property as security for any and all sums of money borrowed, for the purpose of erecting improvements upon the same, it being agreed, however, that the said Trustees shall not become personally liable upnn any note or obligation executed by them, on direction and authorization of said Board of Directors of said Tulsa County Free Fair Association, and the Board of Directors of Tulsa County Free Fair Association shall in the negotiation of any such loan on said property, advise the persons from whom they are receiving the funds that said Trustees shall not become personally liable upon any obligation in connection with such loan,

BE IT FURTHER RESOLVED that in case the said Board of Directors of the said Tulsa County Free Fair Association shall authorize the said Trustees to convey said property, the said Board of Directors of Tulsa County Free Fair Association shall, by resolution adopted by a majority vote of said Board, fix the consideration for the sale of said property, and deliver to said Trustees a certified copy of such Resolution.

BE IT FURTHER RESOLVE) that the Trustees named in said deed of conveyance, being pavid A. Wilson and Exchange Trust Company, shall only be liable for misconduct, and shall only be liable to account for any and all moneys that they shall receive as such Trustee.

BE IT FURTHER RESOLVED that said Trustees, Davis A; Wilson and Exchange Trust Company, shall be under no obligation to look after or pay any taxes which may be assessed and levied against any of said property, that this duty is imposed upon the Board of Directors of the Tulsa County Free Fair Association.

BE IT FURTHER RESOLVED that in case of the death or resignation of the said pavid A. Wilson, one of the Trustees herein, that Exchange Trust Company, of Tulsa, Oklahoma shall be and remain the sole Trustee under said deed from W. A. Vandever and the Tulsa Live Stock & Industrial Exposition, and all acts performed by said Exchange Trust Company as sold Trustee, shall be binding upon said Tulsa County Free Fair Association.

BE IT FURTHER RESOLVED that said Trustees, David A. Wilson and Exchange Trust company, shall be paid by the Tulsa County Free Fair Association a reasonable compensation for any and all services performed by them.
