ORDER AND JUDGMENT

Now on this 11th, day of August, 1923, being one of the regular judicial days of the July, 1923, term of this court, the above cause came on for hearing upon petition of Charles Page praying the Court to vacate, and set aside the order of the Court approving a conveyance and contract in the above cause made and entered on the 7th, day of August, 1923.

The Petitioner appeared by his attorneys, Stuart, Cruce & Bland and Paul P. Pinkerton and the Court, after having seen and heardread said verified petition of said Charles Page, and having heard all the evidence adduced in support thereof and being well and fully advised in the premises finds;

That the allegations of said Charles Page's petition are true and that fraud was practiced upon the Court at the time the Court made and entered the order on August 7, 1923, approving said conveyance and contract of Susie Harjo, now Fife with L. O. Lytle as set out in said Charles Page's petition and that other fraud and misrepresentations were practiced upon the Court in connection with the obtaining the approval of said conveyance and contract and that the Court did not have jurisdiction to make and enter said order approving said deed and contract,

IT IS THEREFORE BY THE COURT ORDERED, ADJUDGED AND DECREED That the order of this Court made and entered on the 7th. day of August, 1923, in the above entitled cause wherein the court approved a contract for attorney's fees and conveyance, executed by Susie Harjo, now Fife, conveying to one L. O. Lytle an undivided one half interest in and to the following described land, situated in Tulsa County, Oklahoma, to wit:

The North East One Quarter (NE $\frac{1}{4}$) of Section Ten (10), Township

Nineteen (19) North, Range Eleven (11) East

be and the same is hereby set aside, vacated and held for naught and the approval of the Court on said instrument is cancelled, withdrawn, set aside and vacated.
