It is further understood and agreed that this bond shall not be valid until authenticated by certificate of C. F. Gordon, Trustee, endorsed upon the back hereof.

This bond shall in all respects be deemed to be, and shall be negotiable instrument and title hereto shall be by delivery, unless this bond be registered. This bond may be registered, as to payment of principal by C. F. Gordon, of Muskogee, Oklahoma, the Trustee and registration noted thereon, as provided, in deed of trust securing this bond; and said principal shall be payable only to the registered holder. After such registration, so noted, no transfer hereof shall be valid, except by transfer on the books of the Trustee, unless the last registration be to bearer. This bond shall continue subject to successive registration and transfer to bearer at option of the holder, coupons for interest on this bond shall in all cases be negotiable by delivery, whether or not this bond be registered, as to principal.

This bond, however, is subject to redemption upon any interest date, at the option of the makers, upon payment to the Trustee, at his office in Muskogee, Oklahoma, of the full amount of the principal hereof, and three per cent (3%) premium hereon, together with all accrued interest to the date of such redemption, provided a sixty days previous written notice of the intention of the makers to exercise such option shall be first given in the manner provided in such mortgage, and provided the bonds of this issue shall only be so redeemed and paid before absolute maturity in their inverse numerical order, beginning with the note of highest serial number then outstanding.
