

REAL ESTATE MORTGAGE

Boswell, Jr. of part V of the second part, the following described real estate and premises situated in Tulsa County, State of Oklahoma, to-wit:

All of Lot Thirteen (13) in Block One (1) in Boswell's Addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof.

This mortgage is subject to a prior mortgage in favor of the Fidelity Building & Loan Association of Shawnee, Oklahoma, in the amount of \$3500.00.

This mortgage is given to secure the principal sum of Twenty Three Hundred Two & 50/100 DOLLARS,

with interest thereon at the rate of 8 per cent, per annum, payable monthly from date

according to the terms of a certain promissory note described as follows, to-wit:

One installment note, bearing date of September 1st, 1923 in the amount of \$2302.50; payable at the rate of \$20.00 per month with accrued interest on the initial payment of \$20.00 for a period of nine months, thereafter a like payment of \$20.00 and accrued interest on unpaid principal sum, the first payment of \$20.00 and accrued interest due and payable on the 1st day of October, 1923; and a like payment of \$20.00 and accrued interest due and payable on the 1st day of each and every month thereafter until the unpaid principal sum with accrued interest has been paid. Interest to accrue at the rate of eight per cent per annum payable monthly from date.

Provided, always, that this instrument is made, executed and delivered upon the following conditions, to-wit: That said first parties hereby covenant and agree to pay all taxes and assessments of said land when the same shall become due, and to keep all improvements in good repair and not to commit or allow waste to be committed on the premises. and to insure, and keep insured in favor of second party, buildings on said premises.

It is further expressly agreed by and between the parties hereto that if any default be made in the payment of the principal sum of this mortgage or any interest installment, or the taxes, insurance premiums, or in case of the breach of any covenant herein contained, the whole of said principal sum, with interest, shall be due and payable, and this mortgage may be foreclosed and second party shall be entitled to the immediate possession of the premises and all rents and profits thereof.

Said parties of the first part hereby agree that in the event action is brought to foreclose this mortgage, will pay a reasonable attorney's fee of Two Hundred Twenty Five & no/100 DOLLARS, which this mortgage also secures.

Parties of the first part, for said consideration, do hereby expressly waive appraisalment of said real estate and all benefit of the homestead, exemption and stay laws in Oklahoma.
