Willbank, party of the second part.Witnesseth: That in consideration of the sum of One & No/100 - - - Dollars and other valuableconsiderations - - - - - DOLLARS,the receipt whereof is hereby acknowledged, said parties of the first part do hereby presents grant, bargain, sell and convey unto said part y of the second part, her heirs and assigns, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:

Lot Five (5) in Block "D", in Joe Sub-Division Located in the Northeast quarter of the Southeast Quarter of Section four (4), Twp. 19 N. R. 12 E. The above land is no part of my homestead and has never been occupied as such.

Subject to the reservation of title in first party, to all oil and gas and other minerals contained in and under said premises, together with the right to produce, mine and remove the same with full right of ingress and egress, and the use of so much of the surface of said premises as shall be necessary thereof. All of which shall be reserved to and retained by first party, his heirs and assigns, in any deed required to be made by first party under this contract.
