**REAL ESTATE MORTGAGE.**

Clarke, party of the second part, the following described real estate and premises situated in Tulsa County, Oklahoma, to-wit:

Commencing at the northwest corner of lot two (2) section 19, township 20 north, range 13 east, thence south two hundred seven and eight tenths feet (207.8'); thence east one hundred feet (100') to a point thence northeasterly three hundred six and two tenths feet (306.2') to the north line of said lot two, (2) thence west three hundred twenty five (325) feet to westline of lot two (2) to beginning, being a part of lot 2 (2) of section nineteen (19) township twenty (20) north, range thirteen (13) east of the Indian Base and Meridian, in Tulsa County, according to the United States survey thereof, together with one Delco system installed on said premises and together with all other appliances and appurtenances placed on said premises or hereafter to be
