Witnesseth: That for and in consideration of the covenants and agreements hereinafter made, the party of the first part covenants, promises and agrees that he will complete a well to the Wilcox sand, in the northeast corner of the southeast (SE_{2}^{+}) of the northwest (NW_{2}^{+}) quarter of section twenty (20) township seventem(17) north, range fourteen (14) east, situated in Tulse County, Oklahoma, said Wilcox said being found at about the depth of 2100 feet, unless oil or gas is found in paying quantities at a less depth.
