Witnesseth, that in consideration of the sum of (\$10500.00) Ten thousand five hundred and no/100 (\$10,500.00) dollars, the receipt of which is hereby acknowledged, said parties of the first part do by these presents, grant, bargain, sell and convey unto said party of the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:
