ORDER APPROVING FULL BLOOD DEED.

Now, on this 13th day of August, 1923, the petition of Susie Harjo, now Fife, for an order approving her warranty deed conveying all her right, title and interest in and to the following described real estate, situate in Tulsa County, Oklahoma, described as follows, to-wit:

The said Susie Harjo, Now Fife, and her husband July Fife, being present in Court and all parties announcing ready for hearings the court examines the petition filed herein and finds that same contains all the information required by law to be stated therein.

Whereupon the court heard all the evidence and at the clase thereof and after due consideration of all evidence adduced and statements of coursel, the court finds, that the said Susie Herjo, now Fife, is a duly enrolled citizen of the Creek Nation of the Full Blood, enrolled on the final approved rolls opposite Roll Number 7152.

The court further finds that Harjo, was a full blood citizen of the Creek Nation, entolled opposite Number 8574, on the final approved rolls of said Nation:

That said Harjo died intestate on or abount the 24th day of May, 1899, in that part of the Creek Nation now embraced in Tulsa County, Oklahoma, and that at the time of his death he had his permanent place of residence in that part of the Creek Nation, now embranced in Tulsa County, Oklahoma and that said Harjo died unmarried and without issue.

The court further finds that said Salman was a full blood citizen of the Creek Nation enrolled opposite Roll Number 8572 on the final approved rolls of the Creek Nation, and that said Salmer died on or about 18th day of June, 1999.

The court further finds the: Fas Tholocco, was a citizen of the Creek Nation of the full blood, enrolled opposite roll number 9959, on the final approved rolls of the Creek Nation and died intestate on or about the 25th day of October, 1899, in and while a resident of that part of the Creek Nation now embraced in Tulse County, Oklahoma; that said Harjo was the child of said Salmer and said Fus Thiocco.
