We further report that the City of Tulsa Oklahoma, the plaintiff in the above cause had found it necessary to take for street purposes a portion of lot ten (10) block forty five (45) Owen addition to the City of Tulsa, and that said city be granted said territory.

We further report that we have considered the injuries which the defendant, as owner of the property hereinbefore described, have sustained or may sustain by reason of the taking of a perpetual right to use for street purposes, the above described portion of land, and we do hereby assess the damages of said owner, by reason of such appropriation of land, at the sum of \$700.00.

REPORT OF COMMISSIONERS.

Comes now the undersigned commissioners, heretofore appointed by the Court, to inspect the real property, hereinafter described and consider the injuries which the defendant A. C.
