Trust Fund to new or other Trustees, or to a corporation, being first duly indemnified for any outstanding obligations or liability. The instrument setting forth such alteration, addition, termination, or conveyance shall be assigned by at least three of the trustees, or otherwise by a resolution concurred in, by at least three of said. Trustees, which said conveyance shall be properly acknowledged and recorded in the office or Registry of Deeds, or County Clerk. Such instruments shall be conclusive of the existance of all facts and of compliance with all perequisites necessary to the validity of such alteration, addition, termination, or conveyance, whether stated in such instrument or not upon all questions as to title or affecting the riggts of third person.

Provided, however, and it is especially declared, that the Trustees shal be under no obligation to termhate this Trust or convey the Prust Fund, except as hereinbefore provided.

### TRUSTEES.
