

ARTICLE IV.
OFFICES

(a) The principal place of business, offices and headquarters of this Trust shall be in the City of Tulsa, Oklahoma, and such other offices may be established and maintained by the Trustees, at such place or places as they may deem advisable.

ARTICLE. COMPARED
PURPOSES OF THE TRUST.

The primary purposes for which this Trust is created, are:

To establish and carry on all or any part of the business of manufacturing, importing, exporting, buying and selling, either as a wholesale or retail merchant or both, any or all of the following classes or merchandise, to-wit: Dry goods, notions, boots and shoes, hats, and wearing apparel generally, linen and cotton goods, silks, furs, laces and other clothing material, groceries and foodstuffs of all kinds, seeds and plants; agriculture and farm implements; furniture, carpets, matting, china and glassware, stoves, heaters, ranges, coal and other kinds of fuel; and generally and without limitation, to deal in and handle all kinds of merchandise usually sold or which may conveniently be sold in connection with any of the merchandise hereinabove referred to, receiving same on consignment, purchasing and selling same directly or on commission.

ARTICLE VI.

Powers of Trustees

The Trustees are hereby duly authorized and fully empowered to acquire by purchase, lease, or otherwise, suitable ground, space and buildings, and to furnish and occupy the same, as in the judgment of the Trustees shall be proper, sufficient and necessary for the use and benefit of the said business or businesses, or any part thereof;

To establish, conduct and carry on the business of manufacturing, importing, exporting, buying and selling, either at wholesale or retail or both, any or all of the following classes or merchandise, to-wit:

Dry Goods, notions, boots and shoes, hats, and wearing apparel generally, linen and cotton goods, silks, furs, laces and other clothing materials; groceries and foodstuffs of all kinds, seeds and plants, agricultural and farm implements; furniture, carpets, matting, china, and glassware, stoves, heaters, ranges coal and other kinds of fuel; and generally and without limitation, and to deal in and handle all articles of merchandise usually sold or which may conveniently be sold in connection with any of the merchandise hereinabove referred to, and they are authorized to receive same on consignment, purchase directly or on commission, and they are fully authorized and empowered organize and classify the said business or any part thereof in such manner and form as in their judgment is for the best interest of this Trust, and to departmentize the same and to conduct and carry on the mercantile business both at wholesale and retail or either.

To invest from time to time, any moneys under the control of the Trustees, in any securities or property which the Trustees may select, in the same manner and to the same extent as if they were not Trustees but were acting individually, in their individual capacity, and without limitation in respect to the character of the securities and properties, and to sell or otherwise dispose of such investments, and to re-invest the proceeds thereof, or any part thereof, with continuing powers to invest and re-invest such funds during the existence of this Trust.
