This stipulation made and entered into this 1st day of Fely 1927 (this change O.K.
O.K. W.F.Pyle,/Carrie Drum, O.K.W.R.Drum) by and between Carrie A. Drum, and W. R. Drum, her husband, parties of the first part, and Roxanna Patroleum Corporation. a corporation organized under the laws of the State of Virginia party of the second part:

Witnesseththat;

Wheres, on the 24th day of November, 1920, Carrie A. Drum, and W. R. Drum, her husband, made, executed and delivered to W. L. Herring a certain oil and gas mining lease covering the following described land, situated in Tulsa County, State of Oklahoma, to-wit:

"Southwest quarter (SW $\frac{1}{2}$) of section 33, township 19 north, range 10 east", and

Whereas said oil and gas mining lesse appears for record in the office of the County Clerk of Tulsa County, Oklahoma, in book _____ page ____; and

Whereas. The Roxanna Petroleum Corporation has acquired said Oil and Gas mining lease and the rights granted thereby by assignment thereof; nand

Whereas, the term of said lease as specified therein is three years from

November 24, 1920, and as long thereafter as oil and gas or either of them is produced from
the said land by the leasee; and

Whereas, it is the desire of the parties hereto to extend the term thereof;

Now, therefore, for and in consideration of the sum of five dollars in hand paid,
