ORDER.

Now, on this 28th day of July, 1923, comes on for hearing the petition of Timmie Fife, guardian of James Marshall, a minor, for the approval of a centain contract made and entered into on the 25th dayof July, 1923, between the said Timmie Fife, as guardain and O. K. Eysenbach, Huldah C. Cook andBessie C. Eysenbach. and the court after hearing evidence submitted finds that the said James Marshall , a minor, is an heir at law of Charles Marshell, deceased a full blood Creek Indian, entolled opposite Number 3 229, and to whom was allotted, among other lands, the northeast quarter of northeast quarter of section 13, township 17 north, range 12 east, situated in Tulsa County, Uklahoma, and that the said James Marshall, a minor, inherited an undivided onethird interst in and to the above described land.

The court further finds that on the 10th day of February, 1912, the said guardian made, executed and delivered an oil and gas mining lease covering the above described real estate to ^J. H. Winemiller, which said lease was fully approved by the County Court of Creek County, on the said 10th day of February, and that the said 0. *I*K Sysenbach Huldah C. Cpok and Bessie ^C. Eysenbach, by means conveyances are not the owners of said o il and gas mining leases and allfights thereunder.

The court funther finds that under an order of sale heretofore entered, said Guardian was authorized to sell the interest of said minor in and to said real estate to the highest and best bidder for cash and that ⁰. JK Eysenbach was and is the highest and best bidder for said land and that said sale was on the 25th day of July, 1923, duly confirmed by this court and that said guardian has made, executed and delivered his said deed conveying to the said U: K. Eysenbach all the right , title and interest of said minor in and to the above described real estate.

The court further finds that under the decisions of the Supreme Court of the State of Oklahoma and the United States Circuit Court of sppeals for the Eighth Circuit, that the said oil and gas mining lease heretofore made by the said guardian and approved by this court is valid and biming.

The court further finds that the said 0. K.Eysenbach and associates have, by virtue of said agreement, offered to pay said minor an additional consideration of \$25.00 at he time to settle all damages by virtue or the development of said land for oil and gas purposes that have hereto fore accrued to said mhor, if any, and in full for any cause of action that may hereafter accrue to said mhor.

The court further finds that it is menifestly to the best interestof said mnor that said guardian execute said contract and accept the said sum of \$25.00 for the use and benefit of said minor.

Now, therefore, it is ordered. adjudged and decreed by the court, that the said contract heretofore entered into on the 25th day of July, 1923, by and between Timmute Fife, as guardian of James Marshall, a minor, as party of the firstpart, and O. K. Eysenbach and associates as parties of the second part, be and the same is hereby approved.
