It is expressly understood and agreed by the parties hereto that if the Superintendent for the Rive Civilized Tribes is at any time satisfied that any of the covenants contained herein, or that any of the provisions of any regulations heretofore or that may hereafter be lawfully prescribed by him, have been or are being violated, he may, after ten days' notice to the parties, cancel this lease and that his declaration of cancellation shall be effective without resorting to the courts and without further proceedings, and that the lessor shall be entitled to the immediate possession of the land.
