make arrangements at some store in Skiatook, Oklahoma, wherein said Lena Keeth shall have credit to that amount for the purchase of such necessities as she may desire at the expense of said S. J. Keeth. The meal derived from the corn deposited at the mill shall be divided equally.

It is further understood and agreed that the daughter, Ruth, the son, Leo and the son, Jennings, desire to live with Lena Keeth, and that the son Oren desires to remain with, and live with, S. J. Keeth, and each of said parties agree that said children shall remain with the parents of their choice as aforesaid and that such parent will adequately provide, care for, and educate the children living with him or her.

It is further understood and agreed between said parties hereto that said S. J. Keeth shall keep and retain for his own, absolutely, all of the rest and residue of the property owned by said parties or either of them at this time.

It is further understood and agreed by and between said parties that said Lena Keeth agrees to accept, and does hereby accept, the above mentioned property as a full and complete settlement of all property rights between the said parties, and the said S. J. Keeth does, in the same manner hereby accept the property above mentioned as going to him as a full and complete settlement upon his part of all property rights between said parties. And each of said parties does hereby agree that they will not at any time hereafter contract any debt or incur any charge or liability whatsoever in his or her own behalf against the other, and each of said parties will hold the other party free and harmless from all debts, action, damages and liability incurred by either or them individually.

It is further understood and agreed by said parties that each of said parties shall have access and communication at all convenient and reasonable times with any of said children who shall be living with, or under the control of, the other party.

It is further understood and agreed that these articles of agreement shall be binding upon the heirs, legal representatives and assigns of the several parties hereto or either of them.
