Hall, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey unto the said Sarah A. Hall and unto her heirs and assigns forever, the following lands lying in the County of Tulsa and State of Oklahoma, to-wit;

All of Lot Thirteen (13) in Block Three (3) in the Hunter Addition to the City of Tulsa, County of Tulsa, State of Oklahoma, according to the recorded plat thereof.

TO HAVE AND TO HOLD the same unto the said Sarah A. Hall and unto her heirs and assigns forever, with all appurtenances thereunto belonging.

And we hereby covenant with said Sarah A. Hall, that we will forever warrant and defend the title to the said lands against all claims whatever.
