(l) The following described real estate, situated at or near Madison, in the County of Greenwood, Kansas, covered by lease from The Atchison, Topeka and Santa Fe Railway Company, Lessor:

The stores, repair shops, offices and warehouses, of the Delaware Company located on the real estate described or referred to in sub-paragraphs 1, 2 and 3, of this Subdivision (B), or on any part thereof, or elsewhere, and any and all stores, repair shops, offices and warehouses which the Delaware Company may hereafter construct or acquire, and any and all additions to and extensions of said existing and future stores, repair shops, offices and warehouses, and all the furnaces, boilers, engines, motors, dynamos, machines, machinery, equipment, patterns, molds, belting, shafting, tools, railroad tracks, cars, locomotives, rolling stock, cranes, hoists, motor trucks and other trucks, automobiles, horses wagons, harnesses, office furniture, fixtures, appliances, implements, utensils and apparatus of every kind and description now owned or hereafter acquired by the Delaware Company for use in the operation of said existing and future stores, repair shops, offices and warehouses, and the additions thereto and extensions thereof, it being hereby expressly agreed that any and all property covered by the foregoing description shall be considered as fixtures and appurtenances constituting part of the real property of the Delaware Company.
