ASSIGNMENT OF OIL AND GAS LEASE.

Fitzpatrick, dated November 25th 1922, and the supplements thereto filed for record in the office of the County Clerk in Tulsa County, On the 28th day of November A.D. 1923, and recorded in book _____ at Page _____.
