#### ANNEXATION

#### ORDINANCE NO. 2549.

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa County, Oklahoma, described as follows; to-wit;

Beginning at the southwest corner of Block 3, Sloan Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence East along the South line of said Block 3 a distance of three hundred and forty two (342) feet; thence South along the West line of Lansing Avenue A distance of three hundred and sixty eight (368) feet; thence Southwesterly along the North line of Archer Street a distance of one hundred and forty-one and two-tenths (141.2) feet to a point; thence Southwesterly along the North line of Archer Street a distance of one hundred and fifteen and seventh-tenths (115.7) feet in the North line of the Original Townsite of the City of Tulsa, Oklahoma, according to the official plat thereof, thence West along the North line of said Original Townsite a distance of Ninety-six and one-tenth (96.1) feet; thence North along a straight line to the point of beginning, and declaring an emergency.

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land situated in Tulsa County, Oklahoma, lies contiguous to and adjoins the present corporate limits of the City of Tulsa, Oklahoma, on three (3) or more sides.

WHEREAS, it further appears to the Mayor and Board of Commissioners of said City that the said tract of land hereinafter described abuts said City on three or more sides and should be annexed to the City of Tulsa, and entered within its corporate limits and that said tract of land does not exceed forty acres.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA.
