SECTION 1; That a tract of land abutting on three sides with the corporate limits of the City of Tulsa, Oklahoma, situated in Tulsa County, Oklahoma, more particularly COMPARED described as follows; to-wit;

Beginning at the Southwest corner of Block 3, Sloan Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence East along the South line of said Block 3 a distance of Three hundred and forty-two (342) feet; thence South along the West line of Lansing Avenue a distance of three hundred and sixty-eight (368) feet; thence Southwesterly along the North line of Archer Street a distance of one hundred and forty-one and two tenths (141.2) feet to a point; thence Southwesterly along the North line of Archer Street a distance of one hundred and fifteen and seven-tenths (115.7) feet to the North line of the Original Townsite of the City of Tulsa, Oklahoma, according to the official plat thereof; thence West along the North line of said Original Townsite a distance of ninety-six and one-tenth (96.1) feet; thence North along a straight line to the point of beginning; be and the same is hereby added to and annexed to the said City of Tulsa, Oklahoma, and the corporate limits of said City be and same hereby are extended to include said tract of land for all purposes.

SECTION 2. That the City of Tulm, Oklahoma hereby retains and reserves a perpetual easement and right to enter upon and use any portion of the above described tract of land and to build construct, lay, maintain, after or repair any sewer lines, water lines, gaslines, telephone lines, telegraph lines, electric lines or any other public

SECTION 3. That from and after this ordinance takes effect the real estate described in Section 1, hereof, shall be a part of the City of Tulsa, Oklahoma, and all persons residing therein and all property situated thereon, shall be and are hereby declared to be subject to all respects and particulars to the jurisdiction, control and laws and ordinance of said City of Tulsa, Oklahoma.

SECTION 4. That an emergency exists for the preservation of the public peace, health and safety, by reason whereof, this ordinance shall take effect from and after its passage, approval and publication.

PASSED and the emergency clause ruled upon separately and approved this 24th day of December, 1923.
