Lot One (1), Block Two (2), Elm Park Addition to the  
 City of Tulsa, Oklahoma, according to the Recorded Plat  
 thereof.

PROVIDED, ALWAYS, And these presents are upon the express conditions that, whereas, the said party of the second part at the special instance and request of the parties of the first part, loaned and advanced to

Bernice Ries and Arthur Ries, her husband,

Seventeen Thousand and 00/100

the sum of  
 DOLLARS.

AND WHEREAS, said parties of the first part agree with the said party of the second part, its successors and assigns, to pay all taxes and assessments, general and special, against said lands and improvements thereon, when due, and to keep said improvements in good repair, and to keep the buildings thereon constantly insured in such company or companies as said second party may designate and the policy or policies of insurance constantly transferred to said party of the second part, its successors or assigns; and also to keep said lands and improvements thereon free from all statutory lien claims of every kind, and if any or either of said agreements be not performed as aforesaid then said party of the second part its successors or assigns, may pay such taxes and assessments, and may effect such insurance, for such purpose, paying the costs thereof, and may also pay the final judgment for and statutory lien claims, and may invest such sums as may be necessary to protect the title or possession of said premises, including all costs and for the repayment of all moneys so expended together with the charges thereon as provided by the By-Laws of said Association, these presents shall be security.

For Value Received we promise to pay to the order of TULSA BUILDING AND LOAN ASSOCIATION, the following sums of money viz:

The sum of One Hundred Thirteen and 05/100 DOLLARS,

the same being the monthly dues on the 170 share 3 of the capital stock of said Association, represented and evidenced by the

Certificate therefor numbered 4560 this day pledged by

Bernice Ries and Arthur Ries, her husband

to said Association to secure a loan of

Seventeen Thousand and 00/100

DOLLARS, and the sum of

One Hundred Thirty-five and 15/100

DOLLARS; the same being the interest

due monthly upon said sum so borrowed by us and we promise to pay said Association at its Home Office at Tulsa, Oklahoma,

the said sums of money, amounting in the aggregate to Two Hundred Forty-eight and 20/100 DOLLARS,

on the 15th day of each and every month, and continue such monthly payments for a term of 106 months from the date hereof Dec. 15, 1923.
