WITNESSETH, That said part of of the first part, in consideration of the sum of Fifteen thousand (\$15,000.00) Dollars (\$15,000.00) the receipt of which is hereby acknowledged, do by these presents Grant, Bargain, Sell and Convey unto said part y of the second part his heirs and assigns, the following described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:

Lot number five (5) and the south one (1) foot of lot number six (6) in Block numbered seventy two (72) in the City of Tulsa, County of Tulsa, and State of Oklahoma, according to the official plat of the said city. DOLLARS

TO HAVE AND TO HOLD The same unto the said part of of the second part his heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever, and warrant the same to the same.

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas said David Kahn has on this day executed and delivered his certain promissory note in writing to said part y of the second part, described as follows: for the sum of fifteen thousand dollars (\$15,000.00) due on or before seven (7) months from date, and bearing interest from date at the rate of eight (8) percent per annum until paid, bearing date of May 17th, 1909, signed David Kahn and the first party agreed to keep the buildings insured for \$—

Now, if said part y of the first part shall pay or cause to be paid to said part y of the second part his heirs and assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then this Mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said part y of the second part shall be entitled to possession of said premises. And the said part y of the first part for said consideration do hereby expressly waive an appraisalment of said Real Estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
