WITNESSETH, That said parties of the first part, in consideration of Four Hundred and Fifty Dollars (\$450.00)  
the receipt of which is hereby acknowledged, do hereby these presents Grant, Bargain, Sell and Convey unto said part y of the second part her heirs and  
assigns, the following described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:

to the City of Tulsa Oklahoma

DOLLARS

TO HAVE AND TO HOLD The same unto the said part y of the second part her heirs and assigns, together with all and singular the tenements,  
hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas said Armenta Harrell and Ad  
Harrell have this day executed and delivered one certain promissory note, in writing to said part y of the second part, described as follows:

Promissory note of \$472.50 dated May 26, 1909 payable  
6 months after date to Sarah Fairies or order at Tulsa  
Okla. to bear interest at the rate of 8 per cent per  
annum from maturity & further hereby agrees to  
if this note is not paid to pay all costs necessary  
for collection including ten percent for attorneys fees

Now, if said part y of the first part shall pay or cause to be paid to said part y of the second part her heirs or assigns, said sum of money in the  
above described note, mentioned, together with the interest thereon, according to the terms and tenor of the same, then this Mortgage shall be wholly discharged  
and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the  
same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when  
the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said part y of the second  
part shall be entitled to possession of said premises. And the said part y of the first part for said consideration do hereby expressly waive an appraisalment  
of said Real Estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
