THIS INDENTURE Made this 3rd day of June A.D. 1929, between Ida V. Hatchel of Tulsa County, in the State of Oklahoma, of the first part, and F. A. Gallup of Tulsa County, in the State of Oklahoma, of the second part:

WITNESSETH, That said part of of the first part, in consideration of Five hundred Dollars (\$500.00) the receipt of which is hereby acknowledged, do by these presents Grant, Bargain, Sell and Convey unto said part of of the second part his heirs and assigns, the following described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:

Lot eight (8) in Block five (5) Oak Grove Addition, to the City of Tulsa, Oklahoma.

DOLLARS

TO HAVE AND TO HOLD The same unto the said part of of the second part his heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas said Ida V. Hatchel has this day executed and delivered two certain promissory notes in writing to said part of of the second part, described as follows:

Note No. 1 for two hundred fifty (\$250.00) Dollars, payable in six months bearing interest at 8% Note No. 2 for two hundred fifty (\$250.00) Dollars payable in twelve months bearing interest at 8%

Now, if said part of of the first part shall pay or cause to be paid to said part of of the second part his heirs or assigns, said sum of money in the above described note, mentioned, together with the interest thereon, according to the terms and tenor of the same, then this Mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said part of of the second part shall be entitled to possession of said premises. And the said part of of the first part for said consideration do by hereby expressly waive an appraisalment of said Real Estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
