removed at any time before the expiration of sixty days from the termination of the lease; that he will not permiseany nuisance to be maintained on the premises under his control, nor allow any intoxicating liquors to be sold or given away for any purposes on such premises; that he will not use such premises for any other purpose than that authorized in this lease, and that before abandoning any well he will securely plug the same so as to effectually shut off all water above the oil

And the said party of the second part further covenants and agrees that he will keep an accurate account of all oil mining operations, showing the whole amount of oil mined or removed; and all sums due as royalty shall be a lien on all implements, tools, movable machinery, and other personal chattels used in said prospecting and mining operations, and upon all of the oil obtained from the land herein leased, as recurity for the payment of said royalties.

And the party of the second part agrees that this indenture of lease shall in all respects be subject to the rules and regulations heretofore or that may hereafter be lawfully prescribed by the Secretary of the Interior relative to oil and gas leases in the Creek Nation.

And the said party of the second part expressly agrees that should be or his sub-lessees, heirs, executors, administrators, successors or assigns, violate any of the covenants, stipulations, or provisions of this lease, or fail for the period of sixty days to pay the stipulated monthly royalty provided for herein, then the party of the first part shall be at liberty in half discretion, to avoid this indenture of lease and cause the same to be annualled, when all the rights, franchises, and privileges of the party of the second part, his sub-lessees, heirs, executors, administrators, successors or assigns hereunder shall cease and end without further proceedings.

If the Lessee makes reasonable and bona fide effort to find and produce oil in paying quantity as is herein required of him and such effort is unsuccessful, he
