THIS INDENTURE Made this 8 day of July A.D. 1909, between Wooden Howell & Annie L. Howell of Tulsa County, in the State of Oklahoma, of the first part, and Granite L. Holt of Tulsa County, in the State of Oklahoma, of the second part:

WITNESSETH, That said parties of the first part, in consideration of Three hundred and twenty five Dollars (\$ 325.00) the receipt of which is hereby acknowledged, do by these presents Grant, Bargain, Sell and Convey unto said part of of the second part his heirs and assigns, the following described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:
Lot 3, block 6, Grandview Addition to Tulsa, Indian Territory,
(Now State of Oklahoma)

TO HAVE AND TO HOLD The same unto the said party of the second part his heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever, subject to existing incumbrance

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas said Thomas L. Starnell had & this day executed and delivered 3 certain promissory notes in writing that said part 4 of the second part, described as follows:

One note for 75.⁰⁰ due Aug 19, 1909, dated July 8, 1909, one note dated July 8, 1909 for 75.⁰⁰ due sixty days after date; one note for 175.⁰⁰ dated July 8, 1909, due ninety days after date.

Now, if said part 1st of the first part shall pay or cause to be paid to said part 2nd of the second part Five heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then this Mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said part 2nd of the second part shall be entitled to possession of said premises. And the said part 1st of the first part for said consideration do hereby expressly waive in appraisement of said Real Estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
