WITNESSETH, That said part 188 of the first part, in consideration of the sum of

the receipt of which is hereby acknowledged, do hereby presents grant, bargain, sell and convey unto said part 188 of the second part his heirs  
and assigns, all the following described real estate situated in Tulsa County and State of  
Oklahoma to-wit:

Lots 1 and 2 of Sunset Court, a re-platting of Lots 1 and 2 of Block  
1 of Sunset Park, a sub-division of land in Tulsa, Tulsa County,

That the 188 will warrant and defend the same against the lawful claims of all persons whomsoever. Said first part 188 agree to insure the buildings on said  
premises in the sum of \$45,000.00 for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage. Said first part 188  
agree to pay all taxes and assessments lawfully assessed on said premises before delinquent.

Said first part 188 further expressly agree that in case of foreclosure of this mortgage and as often as any proceeding shall be taken to foreclose same  
as herein provided, the mortgagor will pay to the said mortgagee Three Hundred Fifty Dollars  
as attorney's or solicitor's fees therefor, in addition to all other statutory fees; said fee to be due and payable upon the filing of the petition for foreclosure and the same  
shall be a further charge and lien upon said premises described in this mortgage and the amount thereon shall be recovered in said foreclosure suit and included in any  
judgment or decree rendered in action as aforesaid, and collected, and the lien thereof enforced in the manner as the principal debt hereby secured.
