on account of taxes or assessments dpon said premises or insurances premiums paid by the second part, the full amount so paid, as taxes or assessments, or insurance premiuma, together with interest thereon from the date of such paywent of 10 per cent per cent per ennum.

And it is also agreed that in the event of any default in payment or breach of. any covenant or condition herein , the rents and profits of said premises, are pledged to party of the second part or his assigns, as additional collateral security and said party of the second party or assigns, shall be entitled to possession of the said premises, by receiver, or otherwise, at the option of the party of the second part.

It is further agreed and understood that in computing interest upon this loan in accordance with the stipulation of this bond, and this mortgage, such interest shall in no event, nor in anywise, directly or indirectly, be computed so as to exceed 10 per cent per annum.

5- It is hereby further agreed and understood that this mortgage secures the payment of the principal note and interest herein described, and all renewal, principal or interest notes, that may hereafter be given, in the event of any extension of time for the pay entof said principal deba, to evidence said principal or interest upon the same during the said time of extension.

6- Said parties of the first part, hereby agree in event action is brought to foreclose this mortgage they will pay an attorney 's fee of Ten Dollars (\$10,00) and 10 percent of the amount due thereon, and said attorney's fee shall become due and payable when this note is placed in the hands of an attorney for collection and the sum so due shall become a part of the judgment and sahll be secured by the lein of this mortgage and by any judgment or decree rendered thereon.

8- It is expressly agreed and understood that the party of the second part shall have the right to pay and discharge at his option any and all liens or incumbrances upon said property prior or superior to this mortgage debt, and upon paying and discharging such lien or incumbrance the party of the second part shall be entitled to recover the sam e with interest at 10 per cent upon the amount so paid, from the parties of the first part and said sum shall be and become a part of the mortgage deby secured by these notes and may be recovered in the foreclosure thereof at the option of the party of the second part.
