

#239 147 EC COMPARED RESOLUTION

Resolution ratifying and confirming Amended Plat of Norvell Park Addition to the City of Tulsa, Tulsa County, Oklahoma, and declaring an emergency.

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the original plat of Norvell Park Addition to the City of Tulsa, Tulsa County, Oklahoma, contained certain errors in the descriptive measurements of certain lots; and

WHEREAS it has further been made to appear that a corrected and amended plat of said Addition has been prepared and certified to by S. W. Mitchell, surveyor, under date of the 27 day of August, 1923; and.

WHEREAS, it further appears that the said amended plat does not alter or change the location or measurements of any of the Streets in said Addition, but merely corrects erroneous descriptive measurements of certain lots;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA OKLAHOMA;

SECTION 1; That the amended Plat and particularly the resurvey of Lots One (1) and Nine (9) in Block Three (3) and Lot One (1) in Block Four (4), as shown on said amended plat of Norvell Park Addition to the City of Tulsa, Tulsa County, Oklahoma, made and certified to by S. W. Mitchell, surveyor on the 27 day of August, 1923, be, and the same hereby is ratified, confirmed and approved as correct.

SECTION 2 ; That an emergency exists for the preservation of the public health and safety, by reason whereof this Resolution shall take effect from and after its adoption, and approval,
