assigns, including insufance upon buildings, and recover the same from the first party, with ten per cent, interest, and that any such payments shall be secured hereby the same as if specifically described herein; and that in ease of a foreclosure hereof, and as often as any foreclosure hereof may be filed, the holder hereof may recover from the forst party an attorney's fee equal to ten per cent of the total amount of which such foreclosure is filed or had, which shall be due upon the filing of the petition in foreclosure, and which is secured hereby, and which the first party promises and agrees to pay, together with all costs, including expenses of examination of title in preparation for foreclosure. any expense incurred in litigation or otherwise, including attorney's fees and an abstract of title to said premises, incurred by reason thereon at ten per cent per annum, and this mortging shall stend as security therefor,

It is further agreed that upon a breach of the warranty herein or in the event of default in payment of installments of principal and interest for the space of three months, or nonpayment of insurances premises, taxes, assessments, or other charges, or failure to issure the previses or to pay any premium for any such insurances which may have been a dvenced by said second party, of failure to keep the said improvements in good repair and in a tentantable condition, or in the event any act of waste is committed on said premises, in any of which events the entire debt shall become due and payable at the option of said party of the s econd part, or its assigns, the said party of the second part, or assigns, shall be entitled to a foreclosure of this mortgage, and to have the said premises sold and the proceeds applied towards the payment of the indebtedness due the said second party of its assigns, ascertained in accordance with the terms of the note and contract secured hereby, and that immediately upon filing of the 9 petition in foreclosure the holder hereof shall be entitled to the possession of the said premises, and to collect and apply the rents thereof, less measonable expenditures, to the payments of said, indebtedness, and for this purposes hereof shall be entitled to a receiver, to the appointment of which the mortgagors hereby consents which appointment may be made either before or after the decree of foreclosure, and the holder hereof shall in no case be held to account for any rental or damage other than for rents actually received, the mortgagors hereby waiving any and all damage arising by reason of taking possession of said premises as aforesaid, and for any and all other hamage or liabilities that may occur to said property when in the possession of said mortg gee; and all the covenants and agreements herein contained shall run with the land herein conveyed,
