July, 23, 1923, Tulsa Oklahom,

This contract made this 23rd day of July, 1923, by and between Finus Campbell and Rosa, Campbell. parties of the first part, and J. A. Shadrick, party of the second part for the following described property to-wit;

All the lands lying south of Bird Creek, of the SW $\frac{1}{4}$   
of Section 4, TWP.20, Range 13, which is Twenty acres more or less,

For the term of two years beginning January, 1, 1925, and ending December, 31. 1926.  
for consideration of said contract, party of the second part has this day paid, One hundred and Ten Dollars, this date for said contract. and this is to be a full and complete payment for said land for the term of two years, as above stated.

It is agreed that if any improvements should be put on this said property by party of the second part, he has the right and privilege of removing the same on the termination of this contract.

It is further understood and agreed that party of the second part is to farm the said land in a good farmer like manner and take care of same, and he is not to permit the violation of any laws on said property so far as he knows;

It is further understood and agreed that the termination of this contract shall be two years as heretofore stated without any notice to the party of the second part, and should either parties decide to extend the contract further they should give at least thirty days notice before the termination of this contract, if it is to be carried on further than two years,
