It is ordered, adjudged and decreed by the court that the above shares of said estate of said Ella Gruwell, deceased, be and the same are hereby transferred, vested, assigned and conveyed to the said S. S. Mohrman, sole devisee under the will of Ella Gruwell, deceased, that is to say, all of the personal estate, consisting of seven hundred and five dollars and twelve cents (\$705.12) and an undivided one-third interest in the above described real estate, and the same is hereby vested, assigned and conveyed to him, his heirs and assigns, and,

It is further ordered, adjudged and decreed by the court that the above described shares in the above described estate of said Ella Gruwell, deceased, so as aforesaid set opposite the names of said heirs respectively, be and the same are hereby vested, assigned and conveyed to the said heirs as follows forever:

To S. S. Mohrman, sole devisee and legatee under the will of Ella Gruwell, deceased, All.

To have and to hold the same, together with all and singular the hereditaments and appurtenances thereunto appertaining to the above named S. S. Mohrman, his heirs and assigns forever.
