W. Thompson on August 11, 1923, of record in the office of the County Clerk of Tulsa County, Oklahoma, in book 463, at page 14, covering the following described lands in Tulsa County, Oklahoma, allotted to the heirs of Sah-co-po-chuny Tiger, full-blood Creek Indian, Roll No. 9214, deceased, to-wit:

South forty (40) acres of lot three (3) and the south forty (40) acres of lot four (4) and the south half (S_2^4) of the northwest quarter (NW2) of section five (5) township sixteen (16) north, range thirteen (13) east;
