Smith all right, title and interest of the Cherokee Nation, and of all other citizens of said Nation, in and to the following described land, viz: The east half of the south west quarter of the north east quarter and the west half of the southeast quarter of the northeast quarter of section twenty eight (28) township twenty one (21) north and range fourteen (14) east; and the south west quarter of the northeast quarter of the south east quarter of section three (3) and the south west quarter of the north west quarter of the north west quarter of section ten (10) township twenty two (22) north and range twenty five (25) east, of the Indian Base and Meridian, in Oklahoma, containing sixty (60) acres, more or less, as the case may be, according to the United States Survey thereof subject however, to all the provisions of said Act of Congress.

In witness whereof, I, the Principal Chief of the Cherokee Nation, have hereunto set my hand and caused the Great Seal of said Nation to be affixed this 26th day of March, A.D. 1909.

Homestead Deed 32285.

The Cherokee Nation
(Formerly Indian Territory)
Oklahoma.

To all to whom these presents shall come, greeting:

Whereas, by the Act of Congress approved July 1, 1902 (32 Stat. 716) ratified by the Cherokee Nation August 7, 1902, it was provided that there should be allotted by the Commissioner to the Five Civilized Tribes, to each citizen of the Cherokee Nation, land equal in value to one hundred and ten acres of the average allotable lands of the Cherokee Nation, and

Whereas, it was provided by said Act of Congress that each member of said tribe shall, at the time of the selection of his allotment, designate, or have selected and designated for him, from his allotment, land equal in value to forty acres of the average allotable lands of the Cherokee Nation, as nearly as may be, as a homestead, for which separate certificate shall issue; and,

Whereas, the said Commission to the Five Civilized Tribes, or its lawful successor, has certified that the land hereinafter described has been selected by or on behalf of Walter F. Smith, a citizen of said tribe, as a homestead.

Now, therefore, I, the undersigned, the Principal Chief of the Cherokee Nation, by virtue of the power and authority vested in me by the aforesaid Act of Congress of the United States, have granted and conveyed, and by these presents do grant and convey unto the said Walter F. Smith, all right, title and interest of the Cherokee Nation, and all right, title and interest of the Cherokee Nation, and of all other citizens of said
