Sinclair Oil & Gas Company. Contract.
AGREEMENT.

This agreement, made and entered into this 24th day of September, 1923, by and between Sinclair Oil & Gas Company, a corporation, organized under and by virtue of the laws of the State of Maine, and duly authorized to transact business as a foreign corporation in the State of Oklahoma, party of the first part, hereinafter called "Vendor" and Atlantic Petroleum Corporation, a corporation organized under and by virtue of the laws of the State of Virginia and duly authorized to transact business as a foreign corporation in the State of Oklahoma, party of the second part, hereinafter called "Vendee".

Witnesseth, that,

Whereas, vendor is the owner of a valid oil and gas mining lease covering the following described land situated in the County of Tulsa, State of Oklahoma, more particularly described as follows:

Southeast quarter (SE $\frac{1}{4}$) of section thirty four (34)
township seventeen (17) range fourteen (14) being
the allotment of Chaparney Parnosky.

Whereas, casinghead gas and other gas from which gasoline may be extracted is being produced from the oil wells now located on the lands above described, which gas vendor desires to sell and vendee desires to buy:

Now, therefore, for and in consideration of the sum of one dollar (\$1.00) paid by vendee to vendor, the receipt of which is hereby acknowledged, and in consideration of the performance by the parties hereto of the covenants, obligations, payments, stipulations, undertakings and conditions herein contained and set forth to be paid, kept and performed, it is agreed by and between the parties hereto, as follows:
