Witnesseth, that said party of the first part, in consideration of the sum of one hundred fifteen and --dollars, the receipt of which is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto said party of the second part, his heirs and assigns, all the following described real estate in Tulsa County and State of Oklahoma, to-wit:

East half (E $\frac{1}{2}$ SW4) south west quarter and west half (W $\frac{1}{2}$, SE4)
southeast quarter of section 30, twp. 19 north, range 10 east.

To have and to hold the same, unto the said party of the second part, his heirs and assigns together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining forever;

Provided always, and these presents are upon this express condition, that whereas said grantee has this day executed and delivered one certain promissory note in writing to said party of the second part, described as follows: Note for \$115. int. 10%, date due in 6 mos.
