This indenture, further witnesseth, that the said party of the first part for the better securing the performance of it by the owenent and obligation above mentioned, and the repayment of the said amount with interest thereon from the time of receiving it, the said party of the second part, in the case above mentioned, and in consideration of one dollar paid to said first party, by said party of the second part, the neeipt of which is hereby acknowledged, has granted, sold, conveyed and confirmed, and by these presents doth grant, sell, convey and confirm unto the party pf the second part, and to its successors and assigns forever, all the following described rel , estate lying and being situate in the county of Tulsa, and State of Oklahoma, to-wit:

> The west one hundred (100) feet of lots twenty six, (26) twenty seven (27) twenty eight (28) and twenty nine (29) in block twety nine (29) in the original townsite of the town, now city of Sana Springe, Oklahoma,
