3 BA Now, for and in consideration of the sum of six hundred & no/100 (\$600.09) dollars, in hand paid, the receipt of which is hereby seenowledged, and slaotfor the further consideration of the agreement between the parties hereto, for themselves, their heirs, successors and legel representatives, that intoxicating liquoreshall never be manufactured, sold or otherwise disposed of, as a beverage, in shy place of public resort, and upon the premises hereby granted, or any part thereof, and the express reservation to the seller, his heirs and assigns, that in case that any of the conditions concerning intoxicating liquors are broken by the Purcheser, his heirs, successors, essigns, or legal representatives, then this deed shall become null and void, and all right, title and interest in and to the premises hereby conveyed, shall revert to the said Sand Springs Home, a corporation, its successors and assigns, and the purchaser, by accepting this deed for himself, his heirs, executors, administrators, successors and assigns, concents and agrees to this reservation and condition, as well as to the reservations, conditions and agreements hereinafter set out; the said seller, further, excepting and reserving unto himself, his heirs and assigns, the oil, gas, fire clay, and all other minerals whether the existence thereof is now known or not, lying in and under the premises Mereinafter described, does hereby bargain, sell, convey, and confirm unto the Purchaser, his heirs, succesors and assigns, forever, the following described premises, situated in the town of Sand Springs, County of Tubs, State of Oklahoms, to-wit: Lot number four (4) Block thirty eight (38) Oak Ridge, second addition to the City of Sand Springs, Oklahoma according to the official plat thereof,

To have and to hold the same, together withall and singular the tenements, hereditaments and appurtemances thereunto belonging or in anywise appertaining, and warrant the title to the same, unto the said purchaser, his heirs, successors and assigns, forever, subject 's nevertheless, to the conditions and reservations and agreements hereinbefore and hereinafter a set forth, according to the true intent and meaning thereof.

And the seller, for himself, and his heirs and assigns, dos hereby covenant, promise and agree to and with the purchaser, his heirs, executors, administrators, successors and assigns, that the said premises are free, clear and discharged of and from all former grats, charges, except for improvements as hereinafter stated, taxes, judgements, mortgages and other liens and encumbrances of whatsoever nature and kind.
