SEWER EASEMENT.

Know all men by these presents: That the undersigned, the owner of the legal and equitable title to the following described real estate, situated in the City of Tulsa, Tulsa County, State of Oklahoma, for and in consideration of the sum of one dollar (\$1.00) cash in hand paid by the City of Tulsa, Oklahoma, and other good and valuable considerations, receipt of which are hereby acknowledged, do hereby grant, and convey unto the said City of Tulsa, Oklahoma, a perpetual easement, through, over, under and across the following described property, situated in said City, to-wit:

A strip of ground, as shown by the blue prints on file in the City Engineer's Office of the City of Tulsa, being more particularly described as follows, to-wit:

Beginning at the northeast corner of lot 13, block 7, Sunset Terrace an addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof, thence southerly along the east line of said lot 13, a distance of twenty five (25) feet thence westerly along a straight line to a point on the west line of said lot 13; thence northerly along the west line of said lot 13, a distance of eighteen (18) feet to the northwest corner thereof; thence easterly along the north line of said lot 13, a distance of one hundred and twenty nine and three-tenths (129.3) feet to the point of beginning, for the purpose of permitting the City of Tulsa to construct a sewer line thence, through, over, under and across said property, together with all necessary and convenient appurtenances thereto, and to use and maintain the same, and of affording the City of Tulsa, its officers agents, employees, and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying, excavating, for, laying, constructing, operating, repairing, relaying, and maintaining said sewerline and for the further purpose of enabling
