

Know all men by these presents:

That in consideration of the sum of one dollar abd other good and valuable considerat ions to us pad receipt of which is hereby acknowledged, the Liberty National Bank a national banking corporation, does herby sell, assign, transfer and convey unto the Security National Bank, a national banking corporation of Tulsa, Oklahoma, its successors and assigns, all of its right, title and interest in and tothe rents, hereafter falling due on or from the following described land situated in Tulsa County, State of Oklahoma, to-wit:

Lots eight (8) nine (9) ten (10) eleven (11) twelve (12) thirteen(13) and fourteen (14) block five (5) in Hillcrest addition to the City of Tulsa, Oklahoma, together with the buildings and improvements thereon ,located.

It is understood that the right, title and interest of the Liberty National Bank in 19 and to the rents from the property above described, arises by virtue of an assignment here-tofore executed by E. E. Short, the owner of said property, and delivered to the Libery National Bank of or about the 13th day of April, 1922, which assignment has been duly filed for record in Record No. 406, page 525, in the office of the County Clerk of Tulsa County, State of Oklahoma.

It is further agreed that the said Liberty National Bank of Tulsa, Oklahoma, does hereby assign to the Security National Bank of Tulsa, Oklahoma all of its right, title and interest in and to: the original assignment itself boween the aforesaid &. E. Short and the aforesaid Liberty National Bank,

It is further agreed that the Security National Bank of Tulsa, Oklahoma, understands that the original assignment of rent is executed by E. E. Short for the purpose of securing to the said Liberty National Bank the payment of a note in the original sum of twenty six thousand, one hundred and forty two and 50/100 )\$25,142,50) dollars, executed by the said E. E. Short and wife to the Liberty National Bank, and that said assignment shall be of no further force and effect after the entire indebtedness represented by said; note has been paid in full.
